- 3. With this application, AT&T and SBC Missouri file Interconnection Agreement Missouri Between Southwestern Bell Telephone, L.P., d/b/a SBC Missouri and AT&T Communications of the Southwest, Inc. ("Interconnection Agreement") and Amendment to Interconnection Agreement By and Between Southwestern Bell Telephone, L.P., d/b/a SBC Missouri and AT&T Communications of the Southwest, Inc.
- 4. AT&T and SBC Missouri seek approval of this Interconnection Agreement and Amendment pursuant to Section 252(e)(1) of the Telecommunications Act of 1996 ("the Act"). The Missouri Public Service Commission ("Commission") must approve the Interconnection Agreement and Amendment unless it determines that the Interconnection Agreement and/or Amendment (or any portion thereof): (1) discriminates against a telecommunications carrier not a party to the agreement and/or amendment; or (2) the implementation of such agreement and/or amendment is not consistent with the public interest, convenience, and necessity. See Section 252(e)(2) of the Act.
- 5. AT&T and SBC Missouri state that neither the Interconnection Agreement nor the Amendment (or any portion of either of these documents) discriminates against a telecommunications carrier not a party to the Interconnection Agreement and/or Amendment. AT&T and SBC Missouri further state that the implementation of the Interconnection Agreement and Amendment is consistent with the public interest, convenience, and necessity.

Wherefore, AT&T Communications of the Southwest and Southwestern Bell Telephone, L.P., d/b/a SBC Missouri pray that the Commission approve Interconnection Agreement –

Missouri Between Southwestern Bell Telephone, L.P., d/b/a SBC Missouri and AT&T Communications of the Southwest, Inc. and Amendment to Interconnection Agreement By and Between Southwestern Bell Telephone, L.P., d/b/a SBC Missouri and AT&T Communications of the Southwest, Inc., together with any further and additional relief the Commission deems just and proper.
