

APPLICATION FOR
APPROVAL OF INTERCONNECTION AGREEMENT
UNDER THE TELECOMMUNICATIONS ACT OF 1996

Comes now NEXTLINK MISSOURI, INC (hereinafter "NEXTLINK", or "Applicant") and hereby files this Application for Approval of a new Interconnection Agreement (the Agreement) between Southwestern Bell Telephone Company (SWBT) and NEXTLINK under the Telecommunications Act of 1996 (the Federal Act) and would respectfully show the Missouri Public Service Commission (the Commission) the following:

I. THE APPLICANT

NEXTLINK is a regulated competitive local telecommunications company under the jurisdiction of this Commission with operations in certificated territories in this State. It is a Washington corporation, duly registered and in good standing with the Missouri Secretary of State. Attached as Attachment 1 is a Certificate of Good Standing-Foreign Corporation issued by the Missouri Secretary of State respecting NEXTLINK. NEXTLINK obtained its Missouri certificate of service authority for local exchange and basic local exchange service in Case No. TA-99-48. NEXTLINK and SWBT entered an earlier interconnection agreement which was approved in Case No. TO-99-270. NEXTLINK's corporate capacity, its relationship to this Commission and its operations were part of the record in each of those cases. NEXTLINK directs the Commission to these earlier cases for further information, if needed, about the company.

II. INTERCONNECTION/RESALE AGREEMENT REACHED

NEXTLINK presents to this Commission for approval an Interconnection Agreement negotiated and executed pursuant to the terms of the Federal Act (Agreement, Attachment 2). This Agreement was entered into pursuant to Section 252(a)(1) of the Federal Act, and SWBT and NEXTLINK executed the Agreement effective August 6, 1999. The Agreement contains 39 pages, together with several Attachments and Appendices. This Agreement revises a portion of the original interconnection agreement between the parties, and adds numerous other terms and provisions. There are no outstanding issues between SWBT and NEXTLINK that need the assistance of mediation or arbitration.

IV. REQUEST FOR APPROVAL

NEXTLINK seeks the Commission's approval of the Agreement, consistent with the provisions of the Federal Act. The implementation of this Agreement complies fully with Section 252(e) of the

Federal Act because the Agreement is consistent with the public interest, convenience and necessity and does not discriminate against any telecommunications carrier. The Agreement promotes diversity in providers, and increases customer choices for telecommunications services.

NEXTLINK respectfully requests that the Commission grant expeditious approval of this Agreement, without change, suspension or other delay in its implementation. This is a bilateral agreement, reached as a result of negotiations and compromise between competitors, and intervention by other parties is neither necessary nor appropriate.

V. STANDARD OF REVIEW

The statutory standards of review are set forth in Section 252(e) of the Federal Act which provides as follows:

(e) APPROVAL BY STATE COMMISSION

- (1) APPROVAL REQUIRED.**--Any interconnection agreement adopted by negotiation or arbitration shall be submitted for approval to the State commission. A State commission to which an agreement is submitted to shall approve or reject the agreement, with written findings as to any deficiencies.
- (2) GROUNDS FOR REJECTION.**--The State Commission may only reject --
 - (A)** an agreement (or any portion thereof) adopted by negotiation under subsection (a) if it finds that --
 - (i)** the agreement (or portion thereof) discriminates against a telecommunications carrier not a party to the agreement; or
 - (ii)** the implementation of such agreement or portion is not consistent with the public interest, convenience, and necessity;

VI. MISSOURI LEGISLATION

The negotiated and executed Agreement is consistent with Chapter 392, RSMo 1994 as amended by S.B. 507 of the Missouri Laws of 1996 and effective August 28, 1996.

VII. CONCLUSION

For the reasons set forth above, NEXTLINK respectfully prays that the Commission approve the Agreement expeditiously.




