Scott-

On February 8, 2007 Socket submitted a request for Remote Call Forwarding service in 61 exchanges. Please take notice that CenturyTel must deny this request for service pursuant to Section 6.B.10 of the tariff. In the judgment of CenturyTel such service would interfere with and impede CenturyTel's ability to provide service to other customers. CenturyTel is concerned that Socket, in conjunction with its CLEC affiliate, and consistent with past practices intends to convert the CenturyTel numbers into multi-channel services in order to provision dial-up internet service in a manner that will overload CenturyTel's network.

CenturyTel also notes that the tariff (Section 6.B.11) requires that the service be taken for a minimum three month period. Socket has consistently terminated its prior Remote Call Forwarding Service prior to the minimum three month period. In any event, the required three month minimum period would extend beyond the proposed effective date of CenturyTel's tariff filing to grandfather Remote Call Forwarding Service, thereby further making it inappropriate to provision these service requests
