AMERENUE’S RESPONSE TO STAFF’S REVISED REPORT

COMES NOW Union Electric Company d/b/a AmerenUE (“AmerenUE” or “Company”), and for its Response to the Revised Report filed by the Missouri Public Service Commission (“Commission”) Staff, states as follows:

1. On May 15, 2009, AmerenUE filed its Verified Petition to Change its Infrastructure System Replacement Surcharge with the Commission.
2. On June 12, 2009, the Commission ordered the Staff to file its report regarding its examination of the information no later than July 14, 2009 and also ordered any responses to the Staff report be filed no later than July 24, 2009.
3. On July 14, 2009, the Staff filed its report.
4. On July 24, 2009, AmerenUE requested a 1-week extension until July 31, 2009 to respond to the Staff report due to Staff personnel being unavailable for the Company personnel to discuss certain recommendations.
5. On July 27, 2009, the Commission granted AmerenUE’s request for a 1-week extension.
6. On July 30, 2009, the Staff filed its Revised Report.
7. AmerenUE agrees with Staff’s Revised Report and accepts the recommendations set out in the report.
