## ORDER TO FILE PROPOSED LOCAL PUBLIC HEARING SCHEDULE AND PROPOSED PROCEDURAL SCHEDULE

On August 3, 2018, the Commission issued its order that the Staff of the Commission ("Staff") should file a Supplemental Recommendation or an alternative pleading no later than September 17, 2018. Staff filed its Supplemental Recommendation on September 17, 2018. On September 27, 2018, the Office of the Public Counsel ("OPC") filed a Response to Staff's Supplemental Recommendation, requested a contested hearing, and requested a prehearing conference. Also on September 27, 2018, Confluence Rivers Utility Operating Company, Inc. ("Company") filed a Response to Staff's Recommendation and a Withdrawal of Application as to Wolf Creek Crossing. On October 4, 2018, Staff, on behalf of itself and the Company, OPC, and Lake Perry Lot Owners Association, filed a Status Report stating that OPC had contacted the parties as to potential local public hearings to be held in this matter and stating that the parties intended to file a proposed procedural schedule no later than October 15, 2018. On behalf of itself and the named parties, Staff asked the Commission to issue an order requiring the parties to file a proposed local public

hearing schedule and a proposed procedural schedule no later than October 15, 2018. The Commission will do so.

#### THE COMMISSION ORDERS THAT:

- 1. Confluence Rivers Utility Operating Company, Inc., the Staff of the Commission, the Office of Public Counsel, and Lake Perry Lot Owners Association shall file a proposed local public hearing schedule and a proposed procedural schedule no later than October 15, 2018.
  - 2. This order shall be effective when issued.
