## ORDER DIRECTING NOTICE

On August 10, 2012, the Staff of the Missouri Public Service Commission filed a motion requesting Switched Services Communications, L.L.C. ("Switched Services") certificate of service authority and accompanying tariff to provide intrastate interexchange telecommunication service in the State of Missouri be cancelled. The Commission granted Switched Services a certificate of service authority to provide intrastate interexchange telecommunication service in the State of Missouri in File Number XD-2013-0050.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup> Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the certificate based on Staff's motion.
