**STATUS REPORT**

COMES NOW the Receiver for Ridge Creek Water Company, LLC and Ridge Creek Development Company, LLC (“Receiver”), and, for his status report, states the following to the Missouri Public Service Commission (“Commission”):

1. On November 15, 2018, the Commission issued its order approving the sale of the assets of the Ridge Creek water system to the City of St. Robert, Missouri (“City”).
2. In order for the City to close on the sale of the water system, it must secure the water system’s ownership of the water system assets by obtaining easements from private property owners for the wells and other infrastructure.
3. As reported in past status reports, the City has encountered several title and ownership issues regarding the water system assets that have taken more time to resolve than originally anticipated.
4. Since the wells and other water system assets are located on private owners’ real property, the City asked its City Engineer to perform surveys and develop easement descriptions for each piece of property so that the City can attempt to obtain consent utility easements.
5. The City now has completed the surveys for all of the system’s 22 wells, and is actively working on getting signatures of the property owners granting the necessary easements.

It has been a slow process. Also the City has also been dealing with some unrelated legal matters that have been keeping the City Attorney busy. The City hopes to have all of this wrapped up by June or July of this year. Both the City and Receiver understand the importance of completing the transaction as soon as possible.

6. The Receiver will file future status updates with the Commission on the progress of the City's work to obtain the proper easements.

WHEREFORE, Receiver respectfully requests that the Commission accept this status report.
