RESPONSE TO ORDER DIRECTING STAFF TO FURTHER RESPOND TO REQUEST FOR EXPEDITED RULING

COMES NOW the Staff of the Missouri Public Service Commission ("Staff") by and through the Office of the General Counsel and respectfully submits as follows:

- 1. On May 11, 2000, Miller Telephone Company ("Miller") and Townes Telecommunications, Inc., ("Townes") filed a Joint Application with the Missouri Public Service Commission ("Commission") requesting that the Commission issue an Order authorizing Townes to purchase all of the issued and outstanding capital stock of Miller.
- 2. The Joint Applicants also filed a Motion to Expedite consideration and approval of this transaction on May 11, 2000.
- 3. On June 2, 2000, Staff filed a Response to Request for Expedited Ruling setting forth its reasons for opposing the Motion to Expedite Ruling in this case.
- 4. On June 7, 2000, the Commission issued an Order Directing Staff to Further Respond to Request for Expedited Ruling
- 5. Staff has served Data Requests on Counsel for Joint Applicants. Staff has received objections to these Data Requests from Counsel for Joint Applicants and has been and will continue to be in contact with Counsel for Joint Applicants striving to resolve these matters.

- 6. Staff believes that if these Data Requests were very promptly and fully responded to (on or before June 26, 2000) then Staff could file a recommendation by July 31, 2000.
- 7. Staff will not be able to adequately review the Joint Application without the information sought in the Data Requests.

WHEREFORE, Staff respectfully requests that the Commission overrule the Motion to Expedite.
