APPLICANTS' RESPONSE TO ORDER DIRECTING FILING

1. On July 18, 2017, 188 North Summit, LLC and Seges Partners Mobile Home Park, LLC ("Applicants") filed a joint application with the Commission seeking authority for 188 North Summit, LLC to purchase substantially all of the water and sewer assets of Seges Partners Mobile Home Park, LLC. 188 North Summit, LLC also applied for a certificate of convenience and necessity to provide water and sewer services to customers presently served by Seges Partners.

2. On August 25, 2017, the Staff of the Commission filed a recommendation ("the Staff Recommendation") to approve the application subject to several conditions enumerated in the subparagraphs of paragraph 5 of the Staff Recommendation and on pages 4 and 5 of Appendix A thereof.

3. On August 28, 2017 the Commission directed the applicants to respond to the Staff Recommendation, specifically addressing the conditions set out therein and to do so no later than September 6, 2017.

4. Having reviewed each of the conditions and recommendations made by the Staff in the Staff Recommendation, and otherwise being fully advised, the applicants find each and every condition and recommendation acceptable and unobjectionable.

WHEREFORE, Applicants respectfully request the Commission to approve their application subject to the conditions set forth in the Staff Recommendation.
