## REVISED JOINT PROPOSED PROCEDURAL SCHEDULE

1. On August 20, 2012, the Commission issued its Order establishing the jointly proposed procedural schedule of the Parties. 2. During the pre-hearing conference, the Parties agreed that discovery would be expedited to five days for objections and ten days for response.
