**COMES NOW** Missouri-American Water Company (MAWC) and supplements its Application as follows:

1. Attached hereto and marked as **Appendix F** is an ordinance reflecting the franchise agreement between MAWC and the Village of Saddlebrooke, Missouri, as described in paragraph 8 of the Application, which was passed by the Board of Trustees on December 7, 2011, and approved by the Chairman on December 8, 2011.
  
2. Attached hereto and marked as **Appendix G** is an Amendment to the Asset Purchase Agreement (“APA”), which amends Appendix E to the Application. The parties amended the APA to provide for connection fees for water and sewer totaling \$5,600 (\$2,800 for water and \$2,800 for sewer) for up to 200 lots.

**WHEREFORE**, MAWC requests the Commission consider this supplemental information and, thereafter, grant MAWC's Application.


