MOTION FOR EXTENSION OF TIME FOR FILING RESPONSE TO APPLICATION FOR REHEARING

COME NOW the Office of the Public Counsel, AG Processing, Inc. a cooperative, and the Sedalia Industrial Energy Users' Association (collectively "Signatories") and for their Motion for Extension of Time for Filing Responses to GMO's Application for Rehearing respectfully state as follows:

- 1. On May 4, 2011, the Commission issued its Report and Order in this proceeding. Late on Friday, May 13, 2011, GMO filed its Application for Rehearing of various portions of the Commission's Report and Order. The Commission has ordered responses to the GMO Application for Rehearing to be filed on May 20, 2011.
- 2. While endeavoring to meet the Commission's May 20, 2011 deadline, the undersigned parties have been unable, as a result of other Commission business, to prepare their responses. Specifically, undersigned counsel was involved in an evidentiary hearing in Case No. EO-2008-0216 on Monday; a hearing regarding the rewrite of the Commission's Chapter 2 rules on Thursday; and an evidentiary hearing in Case No. ER-2011-0038 on Friday. In addition, counsel has been deeply involved in recent efforts to settle Empire's pending rate case, Case No. ER-2011-0004. The obvious implication of all of these Commission proceedings is that counsel has been unable to devote the necessary time to the preparation of their responses.

3. It is also important to recognize that GMO's Application for Rehearing is 32 pages and addresses numerous different topics. Therefore, responding to this Application involves much more work and time than responding to a simple 2 page Application. The scope of the GMO Application for Rehearing, in addition to the other pending Commission proceedings, has made it impossible for undersigned counsel to complete any response to the GMO Application for Rehearing.

4. Given the impossibility of preparing their Applications for Rehearing, counsel asks that it be granted an extension and be permitted to file their response to the GMO application on May 23, 2011. By granting this extension, the Commission should still have plenty of time to review the response to the GMO Application in time for its deliberations in the May 25 scheduled agenda.

WHEREFORE, the Signatories respectfully request that the Commission grant it an extension for filing of its Response to the GMO Application for Rehearing until May 23, 2011.
