ORDER CANCELING CERTIFICATE

Issue Date: June 30, 2016

Effective Date: July 10, 2016

This order cancels the private pay telephone certificate of Teletrust, Inc.

On June 13, 2016, the Staff of the Missouri Public Service Commission filed a motion requesting Teletrust's certificate to provide private pay telephone service in the State of Missouri be canceled.

In Case Number TA-97-277, the Commission granted Teletrust a certificate of service authority to provide private pay telephone service in the State of Missouri via customer-owned coin-operated telephone equipment.

Staff's motion states Teletrust failed to file Statements of Revenue for calendar years 2014 and 2015. It did not pay its Fiscal Year assessment of \$46.77. Teletrust's telephone was disconnected as of April 1, 2016, and the US Postal Service returned mail on April 12, 2016. Staff recommends that the Commission cancel Teletrust's certificate of service authority as the company is no longer providing service in Missouri.

On June 15, 2016, the Commission issued an Order Establishing Time to Respond to Motion allowing anyone to file a response or request a hearing to do so no later than June 27, 2016. No responses were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo (Supp. 2013), which states, in part, "[a]ny certificate or service


authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the private payphone certificate granted to Teletrust, Inc., shall be canceled.

THE COMMISSION ORDERS THAT:

1. The private payphone certificate granted to Teletrust, Inc., in Case Number TA-97-277, is canceled.
2. This order shall become effective on July 10, 2016.
3. This case may be closed on July 11, 2016.




