**ORDER APPROVING TARIFF SHEETS FILED
IN COMPLIANCE WITH COMMISSION ORDER**

On June 25, 1998, the Commission issued a Report and Order that required Union Electric Company d/b/a AmerenUE (AmerenUE) to file tariff sheet changes to reflect a permanent variance from 4 CSR 240-10.020(11). On August 6 AmerenUE filed the tariff sheets required by the Commission's order.

On August 18 the Staff of the Missouri Public Service Commission (Staff) filed a memorandum to the official case file. Staff states that it has reviewed the tariff sheets and is of the opinion that they comply with the Commission's order.

The Commission has reviewed AmerenUE's tariff filing and the Staff's memorandum. Based on the Staff's memorandum, the Commission finds that the tariff sheets should be approved for gas and electric service rendered on and after October 1, 1998.

IT IS THEREFORE ORDERED:

1. That Tariff No. 9900100, submitted in File No. EO-98-263, by Union Electric Company d/b/a AmerenUE on August 6, 1998, is hereby approved for gas service to be rendered on or after October 1, 1998:
