ORDER APPROVING TARIFF

LCI International Telecom Corp. (LCI) filed revisions to its P.S.C. Missouri No. 2 tariff on July 30, 1997 (file number 9800090). The company filed substitute sheets on August 14 and 15. LCI's filing was designed to add Campus Talk Options to its Campus Talk Dedicated Service. The Staff of the Commission (Staff) filed a motion to suspend the tariff filing on the grounds that its approval would result in rate discrimination in violation of Section 392.200.2, RSMo Supp. 1996. The Commission granted the motion, suspending the effective date of the tariff sheets until July 13, 1998, or until otherwise ordered by the Commission.

The parties met in an early prehearing conference and were directed to file a proposed procedural schedule or a stipulation and agreement no later than November 12. Staff filed its Staff Suggestion Concerning Procedural Schedule on November 12, stating that LCI had withdrawn the tariff pages to which Staff had originally objected. Staff stated that it was in the process of preparing a recommendation advising approval of the remaining tariff sheets in the filing. Staff filed its recommendation on November 20 but the company filed substitute sheets after that date. The Staff's final recommendation was filed on January 8, 1998.

Staff stated that the filing, as it has been amended, introduces Menu Routing for Enhanced 800/888 Features. LCI also proposes a no-charge directory assistance credit for presubscribed customers with visual or physical impairments. LCI clarifies its rate for geographical routing associated with its Simply Guaranteed Plus - Enhanced Toll Free Service. Staff stated that the tariff as amended is acceptable and recommended that the Commission approve it at its earliest convenience.

The Commission has reviewed the tariff sheets, the pleadings, and Staff's two recommendations, and finds that LCI's proposed tariff is reasonable and should be approved. The proposed tariff filed by LCI on July 30, 1997 should be approved as amended to become effective on January 30, 1998.

IT IS THEREFORE ORDERED:

1. That the tariff sheets filed by LCI International Telecom Corp. on July 30, 1997 are approved as amended to be effective on January 30, 1998. The tariff sheets approved are:
