ORDER APPROVING CERTIFICATE OF CONVENIENCE AND NECESSITY

This Application was filed on March 20, 1997 by Kansas City Power & Light Company (KCPL) requesting the Commission issue a Certificate of Convenience and Necessity in the form of a line certificate, allowing KCPL to relocate three 161 kV power lines in the service territory of Missouri Public Service in Platte County, Missouri. In its Application KCPL explains that the three power lines are being relocated to accommodate construction of a new residential area and golf course by Tiffany Greens, Inc. The Application reflects that Tiffany Greens, Inc. will pay the costs of the proposed relocation. KCPL has also attached a map of the proposed rerouted lines and obtained permission from Missouri Public Service for the proposed routes.

On March 26 the Commission issued an Order and Notice providing that any proper person wishing to intervene in this matter should do so no later than May 1, 1997. No applications to intervene were received.

On June 17 the Staff of the Commission (Staff) filed its recommendation. In that recommendation, Staff states that construction will be performed by Tiffany Greens, Inc., thus causing a minimum impact

on KCPL and the public. After inspection of the site, Staff states that relocation of the lines will have no apparent negative impact on the public or KCPL customers. Staff recommends approval of the Application.

The Commission finds no detriment to the public from issuance of the requested certificate to relocate power lines as set out in the Application. The Commission will approve the Application and grant KCPL a Certificate of Convenience and Necessity, as set out herein, to construct, own, operate and maintain the three specified 161 kV power lines in a portion of the service territory of Missouri Public Service in Platte County, Missouri.

IT IS THEREFORE ORDERED:

1. That a Certificate of Convenience and Necessity is hereby issued to Kansas City Power & Light Company to construct, own, operate and maintain three 161 kV power lines in a portion of the service territory of Missouri Public Service located in Platte County, Missouri, as set out in the Application in this case. This certificate is a line certificate only.

2. That Kansas City Power & Light Company is hereby ordered to file tariff sheets no later than September 15, 1997 which reflect the Commission's issuance of this certificate and which contain the concise route descriptions of the instant 161 kV lines together with a map showing the location of the 161 kV lines and the territorial boundaries granted in this certificate.

3. That this order shall become effective on September 5,
1997.
