ORDER APPROVING TARIFFS IN COMPLIANCE WITH COMMISSION ORDER

On July 16, 1997 the Commission issued its Report and Order in this matter approving a Stipulation and Agreement between the parties and ordering Empire District Electric Company (EDE) to file tariffs in compliance therewith.
