ORDER APPROVING TARIFF

On August 27, 1998, the Commission issued a Report and Order in this case which rejected the tariff sheets previously filed by ALLTEL Missouri, Inc. (ALLTEL) and directed ALLTEL to file tariff sheets in conformance with the preferences expressed by the Commission in that Report and Order. ALLTEL filed the revised tariff sheets on September 28.

The Commission's Staff reviewed the tariff sheets in light of the Commission's Report and Order and filed a memorandum on October 14 recommending that the Commission approve the proposed tariff sheets. The Staff found that the proposed tariffs are revenue neutral. The Staff also found that the proposed tariff's rates would result in originating minutes of use generating 47 percent of the revenue and terminating minutes of use generating 53 percent of the revenue. The Staff found that the proposed interLATA and intraLATA are not in parity, that the proposed rates will result in a terminating to originating ratio of 1.8:1 for both intraLATA and interLATA, and that the tariffs proposed by ALLTEL will eliminate the intraLATA Carrier Common Line (CCL) cap.

The Commission has reviewed the tariff sheets and Staff's recommendation and finds that the revised tariff sheets conform to the Commission's Report and Order of August 27 and should be approved to become effective on October 28.

IT IS THEREFORE ORDERED:

1. That the revised tariff, tariff filing number 9900245, filed by ALLTEL Missouri, Inc. on September 28, 1998, is approved to become effective on October 28, 1998. The tariff approved is:


