ORDER APPROVING TARIFF FILED IN COMPLIANCE WITH COMMISSION ORDER

On March 9, 2000, the Commission approved a stipulation and agreement filed by the Staff of the Public Service Commission (Staff), AquaSource Development Company (AquaSource), and the Office of the Public Counsel (Public Counsel). The stipulation and agreement provided that a certificate of convenience and necessity should be granted to AquaSource to construct, install, own, operate, control, manage and maintain a system for the provision of sewer service to serve a new service area in Morgan County, Missouri. The Commission's order directed AquaSource to file, no later than April 10, 2000, a 30-day tariff reflecting the proposed initial tariff attached to its application with the modifications shown on attachment 1 of the stipulation and agreement.

AquaSource filed tariff sheets on April 10, with an effective date of May 10. The Commission's Staff reviewed the tariff sheets and filed a recommendation and memorandum on April 28, indicating that the

submitted tariff filing is in compliance with the Commission's order of March 9. The memorandum recommends that the Commission approve the submitted tariffs effective on May 10, the requested effective date.

The Commission has reviewed the tariff sheets and Staff's recommendation and finds that the tariff sheets conform to the Commission's order of March 9 and should be approved to become effective on May 10, for service rendered on and after May 10.

IT IS THEREFORE ORDERED:

1. That the tariff filed by AquaSource Development Company on April 10, 2000, and assigned tariff number 200000926, is approved to become effective on May 10, 2000. The tariff approved is:
