ORDER APPROVING INTEREXCHANGE AND NON-SWITCHED LOCAL EXCHANGE
CERTIFICATES OF SERVICE AUTHORITY AND ORDER APPROVING TARIFF

Enhanced Communications Network, Inc. (ENC) applied to the Public Service Commission on December 7, 1998 for certificates of service authority to provide intrastate interexchange and non-switched local exchange telecommunications services in Missouri under Section 392.410-.450, RSMo 1994, and RSMo Supp. 1997¹. ENC asked the Commission to classify it as a competitive company and waive certain statutes and rules as authorized by Sections 392.361 and 392.420. ENC is a Delaware corporation, with its principal office located at 37 Winthrop Place, Hazlet, New Jersey 07730.

The Commission issued a Notice of Applications and Opportunity to Intervene on December 15, 1998, directing parties wishing to intervene to file their requests by December 30, 1998. The requirement for a hearing is met when the opportunity for hearing has been provided and no proper party has requested the opportunity to

present evidence. State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494, 496 (Mo. App. 1989). Since no one has asked permission to intervene or requested a hearing, the Commission may grant the relief requested based on the verified application.

ENC filed a proposed tariff in conjunction with its application and filed substitute sheets on January 7, 1999. The tariff's effective date is January 21, 1999. ENC's tariff describes the rates, rules, and regulations it intends to use, identifies ENC as a competitive company, and lists the waivers requested. ENC intends to provide interexchange and non-switched local exchange telecommunications services including 1+ dialing, directory assistance, private line and debit card services.

In its Memorandum filed on January 11, 1999, the Staff of the Commission stated that ENC's proposed services are similar to existing IXC offerings. Staff recommended that the Commission grant ENC a certificate of interexchange service authority, and a certificate of service authority for local exchange telecommunication services on condition that this authority be restricted to providing dedicated, non-switched local exchange private line services. Staff recommended that the Commission grant ENC competitive status, and waiver of the statutes and rules listed in the Notice. Staff recommended that the Commission approve the proposed tariff as amended to become effective on January 21, 1999.

The Commission finds that competition in the intrastate interexchange and non-switched local exchange telecommunications

markets is in the public interest and ENC should be granted certificates of service authority. The Commission finds that the services ENC proposes to offer are competitive and ENC should be classified as a competitive company. The Commission finds that waiving the statutes and Commission rules set out in the ordered paragraph below is reasonable and not detrimental to the public interest.

The Commission finds that ENC's proposed tariff details the services, equipment, and pricing it proposes to offer, and is similar to tariffs approved for other Missouri certificated interexchange and non-switched local exchange carriers. The Commission finds that the proposed tariff filed on December 7, 1998 shall be approved as amended to become effective on January 21, 1999.

IT IS THEREFORE ORDERED:

1. That Enhanced Communications Network, Inc. is granted a certificate of service authority to provide intrastate interexchange telecommunications services in the State of Missouri, subject to the conditions of certification set out above.

2. That Enhanced Communications Network, Inc. is granted a certificate of service authority to provide local exchange telecommunications services in the State of Missouri limited to providing dedicated, non-switched local exchange private line services, subject to all applicable statutes and Commission rules except as specified in this order.

3. That Enhanced Communications Network, Inc. is classified as a competitive telecommunications company. Application of the following statutes and regulatory rules shall be waived:
