## MOTION TO MODIFY PROCEDURAL SCHEDULE

COMES NOW the Office of the Public Counsel and for its Motion to Modify Procedural Schedule states as follows:

- 1. In its September 5, 2012 Order Directing Notice, Setting Intervention Deadline, Directing Filing and Scheduling a Conference, the Commission set a joint procedural conference. As a result of that conference and further discussions, the parties proposed a procedural schedule on November 2, 2012.
- 2. The Commission adopted that schedule in an order issued November 7, 2012. After the parties proposed the schedule and the Commission approved it, the undersigned attorney became aware of a scheduling conflict for the week of the evidentiary hearing. Public Counsel has conferred with the parties about moving the evidentiary hearing to the week following the week in which it is currently scheduled, and similarly moving post-hearing events.
