ORDER APPROVING INTEREXCHANGE CERTIFICATE OF SERVICE AUTHORITY AND ORDER APPROVING TARIFF

HJN Telecom, Inc. (HJN) applied to the Public Service Commission on June 30, 1998, for a certificate of service authority to provide intrastate interexchange telecommunications services in Missouri under Section 392.440, RSMo 1994. HJN asked the Commission to classify it as a competitive company and waive certain statutes and rules as authorized by Sections 392.361 and 392.420. HJN is a Georgia corporation, with its principal office located at 3235 Satellite Boulevard, Building 400, Suite 300, Duluth, Georgia 30096.

The Commission issued a Notice of Applications and Opportunity to Intervene on July 14, directing parties wishing to intervene to file their requests by July 29. The requirement for a hearing is met when the opportunity for hearing has been provided and no proper party has requested the opportunity to present evidence. State ex rel.

Rex Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494, 496 (Mo. App. 1989). Since no one has asked permission to intervene or requested a hearing, the Commission may grant the relief requested based on the verified application.

HJN filed a proposed tariff in conjunction with its application and filed substitute sheets on July 8. The tariff's effective date is August 15. HJN's tariff describes the rates, rules, and regulations it intends to use, identifies HJN as a competitive company, and lists the waivers requested. HJN intends to provide interexchange telecommunications services including 1+ direct dial, 800/888/877, directory assistance, debit card, and travel card services.

In its Memorandum filed on August 6, the Staff of the Commission stated that HJN's proposed services are similar existing IXC offerings. Staff recommended that the Commission grant HJN a certificate of service authority, competitive status, and waiver of the statutes and rules listed in the Notice. Staff recommended that the Commission approve the proposed tariff as amended to become effective on August 15.

The Commission finds that competition in the intrastate interexchange telecommunications market is in the public interest and HJN should be granted a certificate of service authority. The Commission finds that the services HJN proposes to offer are competitive and HJN should be classified as a competitive company. The Commission finds that waiving the statutes and Commission rules set out in the ordered paragraph below is reasonable and not detrimental to the public interest.

The Commission finds that HJN's proposed tariff details the services, equipment, and pricing it proposes to offer, and is similar to tariffs approved for other Missouri certificated interexchange carriers. The Commission finds that the proposed tariff filed on June 30 shall be approved as amended to become effective on August 15.

IT IS THEREFORE ORDERED:

- 1. That HJN Telecom, Inc. is granted a certificate of service authority to provide intrastate interexchange telecommunications services in the state of Missouri, subject to all applicable statutes and Commission rules except as specified in this order.
- 2. That HJN Telecom, Inc. is classified as a competitive telecommunications company. Application of the following statutes and regulatory rules shall be waived:
