MAWC'S RESPONSE TO STAFF'S MOTION TO COMPEL ANSWERS TO DATA REQUESTS

COMES NOW Missouri-American Water Company ("MAWC" or "Company") and, in response to the Commission Staff's ("Staff") Motion to Compel Answers to Data Requests, states to the Missouri Public Service Commission ("Commission") as follows:

- 1. On January 21, 2000, Staff filed its Motion to Compel Answers to Data Requests. This motion requested that the Commission order MAWC to respond to Staff's data requests 3801 through 3810 within five days after an entry of a Commission order compelling such responses.
- On January 27, 2000, MAWC hand delivered to Staff responses to Staff data requests
 3801 through 3810. MAWC had failed to respond previously due to inadvertent oversight.
- 3. MAWC believes that it has responded to the data requests that are the subject of Staff's motion and that suggests that Staff's motion is now moot.

WHEREFORE, MAWC respectfully requests that the Commission issue its order dismissing

the Staff's Motion to Compel as moot.
