## **RESPONSE TO COMMISSION ORDER**

COMES NOW the Director of the Manufactured Homes and Modular Units Program of the Missouri Public Service Commission ("Director"), by and through one of his attorneys, and for his Response to the Commission Order entered September 7<sup>th</sup>, 2000, directing a status report on the above captioned case, states as follows:

This rulemaking is to rescind a chapter of the Missouri Code of State Regulations dealing with recreational vehicles. Pursuant to legislation, the Commission no longer has authority over recreational vehicles. Therefore, rescission of this chapter is sought through the rulemaking process.

The Director currently has a number of rulemaking cases that are at different stages of completion. This particular case is not yet ready to be submitted to the Commission for its review. However, the Director respectfully advises the Commission that a rulemaking packet can be filed for the Commission's review no later than October 24, 2000.

THEREFORE, based upon the foregoing, the Director respectfully requests that the Commission enter an Order allowing the Director until October 24, 2000, to file a Rulemaking packet in this case.
