## PROPOSED PROCEDURAL SCHEDULE

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), on its own behalf and on behalf of Missouri-American Water Company ("MAWC" or "Company"), the Public Water Supply District No. 2 of St. Charles County, Missouri ("Water District"), and the Office of the Public Counsel ("OPC"), and for its Proposed Procedural Schedule states to the Missouri Public Service Commission as follows:

- 1. On February 13, 2001, the Company and the Water District ("Applicants") filed their Joint Application for Approval of Territorial Agreement, wherein they requested that the Commission approve by report and order the Territorial Agreement that the Applicants had executed on October 4, 2000, a copy of which was attached to and made a part of the said Joint Application.
- 2. On February 23, 2001, the Commission issued an Order and Notice which required that notice of this proceeding be sent to interested parties, provided that applications to intervene must be filed by no later than March 15, 2001, and ordered the Applicants, OPC and the Staff to file a proposed procedural schedule by no later than March 26, 2001, with a hearing to be held no later than May 11, 2001.

- 3. OPC and the Staff have begun to investigate this application and the parties believe they can complete and execute a Stipulation and Agreement for presentation to the Commission by no later than April 16, 2001.
- 4. Accordingly, the parties have unanimously agreed to propose the following Procedural Schedule, which will allow the Commission to rule on the Joint Application within 120 days after the filing of the Joint Application, as required by Section 247.172.3, RSMo:

Parties file Stipulation and Agreement

April 16, 2001

Evidentiary hearing

May 1, 2001

WHEREFORE, the Staff requests that the Commission issue an order establishing a procedural schedule as set forth in Paragraph 4 hereof.
