DATE: June 28, 2010

On June 23, 2010, Missouri Gas Energy (MGE or Company), a division of Southern Union Company, of Kansas City, Missouri, filed a tariff sheet bearing an effective date of July 8, 2010. This tariff sheet was filed to reflect a change in MGE's Purchased Gas Adjustment (PGA) factor as a result of estimated changes in the cost of natural gas for the remaining 2010 Summer season. Additionally, this tariff filing reflects changes in the demand related transportation costs of large volume transportation customers.

This filing will increase the firm PGA factor for the 2010 Summer season, to \$.82433 per one-hundred cubic feet (Ccf), from the current PGA factor of \$.69754 per Ccf. This represents an increase of \$.12679 per Ccf.

Case No. GR-2010-0372, under which these changes were filed, was established to track the Company's PGA factors to be reviewed in its 2009-2010 Actual Cost Adjustment (ACA) filing. Case Nos. GR-2008-0367 and GR-2009-0268 were established to track the Company's PGA factors to be reviewed in 2007-2008 and 2008-2009 ACA filings respectively. This rate change should be on an interim, subject to refund status pending final Commission decisions in ACA Case Nos. GR-2008-0367, GR-2009-0268, and GR-2010-0372.

Staff has verified that this company has filed its annual report and is not delinquent on any of its assessment. Staff is not aware of any other matter before the Commission that affects or is affected by this filing.

Staff recommends that the following tariff sheet, filed on June 23, 2010, be approved, interim subject to refund:
