COMES NOW the Staff of the Public Service Commission of Missouri and for its recommendation in this case states:

- 1. On April 27, 2001, Missouri Gas Energy filed tariff sheets (File No. 200101090) to remove the \$2.25 trigger mechanism from its current tariff provisions. On May 15, 2001, MGE filed an additional tariff sheet (File No 200101116) to remove an additional reference to the trigger price mechanism.
- 2. Staff concurs with MGE that removal of these provisions is warranted at the present time. See the Staff Memorandum attached as Attachment A.
- 3. Staff continues to recommend that the Commission reject the alternative incentive proposals filed by MGE on March 30, 2001, in this case.

Staff Recommendation on Tariff Sheets Filed to Modify Missouri Gas Energy's Fixed

Price Commodity Price PGA Effective May 27, 2001.

On March 30, 2001, Missouri Gas Energy, a division of Southern Union Company (MGE or Company) of Kansas City, Missouri, filed Missouri Gas Energy's Alternative Proposal Regarding Commodity Cost Recovery requesting the Missouri Public Service Commission (Commission) issue an Order adopting one of two alternative proposals regarding commodity cost recovery. On April 19, 2001, the Missouri Public Service Commission Staff (Staff) filed its Staff Recommendation outlining the reasons for recommending that the Commission reject both of alternative proposals recommended by MGE. On April 27, 2001, MGE filed Missouri Gas Energy's Response to Staff Recommendation; Request for Expedited Consideration to eliminate the \$2.25 trigger price mechanism that current exists in the Fixed Commodity Price (FCP) Purchased Gas Adjustment (PGA) Section of the Company's tariff. In addition, on April 27, 2001, MGE filed tariff sheets with the Commission, assigned File No. 200101090, that would eliminate the \$2.25 trigger price mechanism as proposed in its Response and Request filed on that same date. On May 15, 2001, MGE filed an additional tariff sheet at the request of the Staff, assigned File No. 200101116, to eliminate one additional phrase relating to the \$2.25 trigger that was inadvertently not filed as part of the original tariff filing. Both tariff sheet filings provide for the required 30 days notice. However, in its Response and Request and its letter accompanying the May 15, 2001 tariff filing, MGE is requesting expedited approval of these tariff sheets, but the Company did not request a specific date. The Company is requesting expedited approval of the tariff sheets because "the presence of the \$2.25 trigger price mechanism unduly complicates gas supply purchasing decisions". In addition, the Company states that the elimination of this trigger "will clarify matters and the sooner it is eliminated and matters are clarified the better."

This filing constitutes Staff's recommendation that the Commission approve the tariff filings of April 27, 2001 and May 15, 2001 and reject Missouri Gas Energy's Alternative Proposal Regarding Commodity Cost Recovery filing of March 30, 2001. Staff does not necessarily agree or disagree with the planned gas procurement actions alluded to in MGE's pleadings but continues to urge MGE to evaluate all hedging alternatives as part of its gas procurement responsibilities.

The Staff has reviewed the Company's tariff sheets filed April 27, 2001 and the tariff sheet filed May 15, 2001, and is of the opinion that good cause for approval of the elimination of the \$2.25 Trigger
