Staff Recommendation to Approve the Transfer of Assets from NeTel, Inc. to OneStar

Long Distance, Inc.

On January 12, 2000, OneStar Long Distance, Inc., (OneStar), filed an application for the approval of the purchase of the NeTel, Inc. (NeTel) customer base. Also on January 12, 2000, OneStar submitted direct testimony of Laura Collier, OneStar regulatory supervisor, to supplement the application.

OneStar was granted a certificate of service authority to provide interexchange telecommunications services in Case TA-98-50. On December 14, 1999, NeTel filed for Chapter 11 bankruptcy with the US Bankruptcy Court of the Southern District of Florida (Docket No 98-28929-BKC-PGH). In connection with its plan for relief under Chapter 11, NeTel solicited offers for its telecommunications assets, and OneStar responded. The parties reached an agreement whereby NeTel would sell all of its existing Dial 1+ Customer Base, receipts and proceeds therefrom and all accounts receivable from the Dial 1+ Customer Base. This agreement was approved by the Bankruptcy Court on July 19, 1999. OneStar updated its tariff to include rate plans similar to those offered by NeTel and began transitioning the NeTel customer base to its service. OneStar reports that the change was not detrimental to the 228 affected Missouri customers. OneStar notified customers of the transition by letter (attached to application) and reports no complaints from customers since the transition.

OneStar states that there are no final judgments against it from any state or federal agency and states that it will be providing the services for NeTel customers under OneStar's current tariff (which has been updated to offer NeTel customers similar rate plans). Additionally, this transaction does not appear to be against the public interest.

The Telecommunications Department Staff (Staff) has reviewed the application for the transfer of assets and has no objections to the proposed transaction. OneStar asked for the transfer to be approved *nunc pro tunc*. However, Staff recommends the Commission issue an order to approve the transfer of NeTel's Dial 1+ Customer Base to OneStar, *prospectively*. The Staff is unaware of any filing which affect or would be affected by this transfer.
