Staff Recommendation to Approve Name Change and Proposed Replacement

On November 23, 1999, Eclipse Telecommunications, Inc. (Eclipse), a competitive telecommunications company, filed a proposed replacement tariff which reflects Eclipse' name change to BroadWing Telecommunications, Inc. Included with the tariff filing is a copy of Eclipse' Amended Certificate of Authority from the Missouri Secretary of State. Eclipse provides interexchange telecommunications services under authority granted by this Commission to Network Long Distance, Inc. d/b/a LDN Long Distance, Inc. (LDN) in Case No. TA-93-296. LDN's name was changed to Eclipse in Case No. TO-99-74.

According to the cover letter, Eclipse made no other changes to the proposed replacement tariff other than change the corporate name. However, the proposed replacement tariff did inadvertently omit some volume and term discounts. At the request of the Telecommunications Department Staff (Staff), Eclipse submitted substitute tariff pages on December 10, 1999. The Staff has no objections to the proposed tariff, as amended, and recommends the Commission issue an order to amend Eclipse' certificate of service authority to provide interexchange telecommunications services and approve the following tariff pages effective December 23, 1999:

The Staff is aware of another filing that was filed in conjunction with this filing. On November 24, 1999, IXC Communications, Inc. filed a tariff to change its name to BroadWing Communications Services, Inc. (Case No. TO-2000-345, Tariff No. 000488). The Staff is also filing a recommendation to approve that proposed name change.
