ORDER APPROVING INTEREXCHANGE CERTIFICATE OF SERVICE AUTHORITY AND ORDER APPROVING TARIFF

ATN Communications Incorporated (ATN) applied to the Missouri Public Service Commission on November 12, 1998, for a certificate of service authority to provide intrastate interexchange telecommunications services in Missouri under Section 392.440, RSMo 1994¹. ATN asked the Commission to classify it as a competitive company and waive certain statutes and rules as authorized by Sections 392.361 and 392.420. ATN is an Indiana corporation, with its principal office located at 1509 Government Street, Suite 500, Mobile, Alabama 36604.

The Commission issued a Notice of Applications and Opportunity to Intervene on November 24, 1998 directing parties wishing to intervene to file their requests by December 9, 1998. The requirement for a hearing is met when the opportunity for hearing has been provided and no proper party has requested the opportunity to present evidence. State ex rel. Rex Deffenderfer Enterprises Incorporated v. Public Service Commission, 776 S.W.2d 494, 496 (Mo. App. 1989). Since

no one has asked permission to intervene or requested a hearing, the Commission may grant the relief requested based on the verified application.

filed a proposed tariff ATN in conjunction with its application and filed substitute sheets on December 9, 1998. The tariff's original effective date December 28; however, was December 9, ATN voluntarily extended the effective date to January 8, ATN's tariff describes the rates, rules, and regulations it intends to use, identifies ATN as a competitive company, and lists the waivers requested. ATN intends to provide interexchange telecommunications services including 1+ direct dial, 800/888/877 Services, Directory Assistance, Operator Services, Debit Card Services and Credit Card Services.

In its Memorandum filed on December 22, 1998 the Staff of the Missouri Public Service Commission (Staff) recommended that the Commission grant ATN a certificate of service authority, competitive status, and waiver of the statutes and rules listed in the Notice. Staff recommended that the Commission approve the proposed tariff as amended to become effective on January 8, 1999.

The Commission finds that competition in the intrastate interexchange telecommunications market is in the public interest and ATN should be granted a certificate of service authority. The Commission finds that the services ATN proposes to offer are competitive and ATN should be classified as a competitive company. The Commission finds that waiving the statutes and Commission rules set out in the

ordered paragraph below is reasonable and not detrimental to the public interest.

The Commission finds that ATN's proposed tariff details the services, equipment, and pricing it proposes to offer, and is similar to tariffs approved for other Missouri certificated interexchange carriers. The Commission finds that the proposed tariff filed on November 12, 1998 shall be approved as amended to become effective on January 8, 1999.

IT IS THEREFORE ORDERED:

- 1. That ATN Communications Incorporated is granted a certificate of service authority to provide intrastate interexchange telecommunications services in the state of Missouri, subject to all applicable statutes and Commission rules except as specified in this order.
- 2. That ATN Communications Incorporated is classified as a competitive telecommunications company. Application of the following statutes and regulatory rules shall be waived:
