**ORDER APPROVING TARIFF SHEETS**  
**IN COMPLIANCE WITH COMMISSION ORDER**

On February 3, 1998, the Commission issued an Order Approving Sale of System and Granting Certificate of Convenience and Necessity to Capital Utilities, Inc. (Capital Utilities). On February 25 Capital Utilities filed tariff sheets to comply with the Commission's order. The tariff sheets bear an effective date of March 27. Capital Utilities filed substitute tariff sheets on March 16 and on March 24 to correct typographical errors.

On March 18 the Staff of the Commission (Staff) filed a memorandum in the official case file which indicated that the tariff sheets filed by Capital Utilities were in compliance with the Commission's order. On March 25 Staff filed a supplemental memorandum indicating that the substitute tariff sheets filed to correct typographical errors were in compliance with the Commission's order. Staff recommended that the Commission issue an order approving the tariff sheets as substituted.

The Commission has reviewed the tariff sheets filed by Capital Utilities and the Staff's memorandum. The Commission finds that the tariff sheets filed by Capital Utilities on February 25, as substituted on March 16 and March 24, are in compliance with the Commission's order.

**IT IS THEREFORE ORDERED:**

1. That the following tariff sheets filed by Capital Utilities, Inc. on February 25, 1998, as substituted on March 16, 1998, and March 24, 1998, are approved and shall become effective for service rendered on and after March 27, 1998:
