APPLICANT'S RESPONSE TO STAFF RECOMMENDATION AND RESPONSE TO MOTION TO CONSOLIDATE AND MOTION TO SUBMIT CASE ON VERIFIED APPLICATION AND STAFF RECOMMENDATION

COMES NOW the Applicant in the above captioned matter, and for its Response to Staff Recommendation, Response to Motion to Consolidate and Motion to Submit Case on Verified Application and Staff Recommendation states as follows.

#### RESPONSE TO STAFF RECOMMENDATION

The Applicant is in agreement with the Conclusions and Recommendations sections of the Staff Report filed herein on December 12, 1997. In particular, the Applicant agrees with Staff as follows:

A Certificate of Convenience and Necessity should be granted to Applicant 1. authorizing the Applicant to provide water and sewer service to the public in the area known as Cedar Glen in Camden County, Missouri, exclusive of the area described in the Application which is located north of U.S. Highway 54.

- 2. Applicant will file a complete tariff pertaining to the provision of sewer service, including a proper map and description of the revised service area upon the granting of said Certificate by the Commission.
- 3. Applicant will file the necessary revisions to its existing water tariff adding thereto the map and description of the Cedar Glen service area, as revised, upon the granting of said Certificate by the Commission.
- 4. Applicant is and will continue to maintain its books and records in accordance with the Commission approved Uniform System of Accounts, and will make such modifications and changes to its accounting procedures as Staff may recommend at the conclusion of its current audit of the Applicant.
- 5. Applicant agrees that an 18 month review period to determine the suitability of the sewer rates is appropriate; that the use of the Applicant's existing water tariff and rates for service to Cedar Glen is appropriate, and that the sewer depreciation rates set out on Attachment 1 to the Staff recommendation are appropriate at this time.
- 6. Applicant does not necessarily agree or disagree with the assertions and conclusions set out in the portion of the Staff Recommendation designated as "The Staff's Investigation," particularly in that said assertions and conclusions are clearly stated to be based upon a pending and as yet incomplete audit of the Applicant, except as said assertions and conclusions support the Conclusions and Recommendations portions of said Staff Recommendation, and reserves the right

to contest or dispute said assertions and conclusions in future certificate and rate cases regarding the Applicant.

#### RESPONSE TO MOTION TO CONSOLIDATE

Applicant concurs and agrees with Staff that the Motion to Consolidate filed herein by the Osage Beach Fire Protection District seeking to consolidate this Application with Cases WA-97-110 and WC-98-211 should be denied because:

- a) Osage Beach Fire Protection District is not a party to this case, has not sought leave to intervene herein, and the time for filing of an Application to Intervene herein expired on August 29, 1997 as established by the Order of the Commission entered herein on July 30, 1997. Notice of Applicant's intent to provide water and sewer service to Cedar Glen was published in the Lake-Sun Leader, a local newspaper in the Lake of the Ozarks Area, on September 23, 1997, and provided the Osage Beach Fire Protection District with actual notice of this proceeding. A copy of the article from said newspaper is attached hereto as Exhibit A.
- Application for a certificate to provide water and sewer service to

  Cedar Glen and Case WC-98-211, which relates to the provision of

  water service by Applicant to an area referred to in the Complaint

  as "Passover Road," and which is located within the City of Osage

  Beach.

- the corporate limits of the Osage Beach Fire Protection District, and in fact are located within the corporate limits of the Mid-County Fire Protection District, such that the Osage Beach Fire Protection District would not be a "municipality" having jurisdiction over the operations of the Applicant within the proposed service areas.
- d) The Motion to consolidate is untimely, in that is was not filed until the date upon which Staff was required by the Commission's Order of October 29, 1997, to file its Recommendation herein.

For these reasons, the Motion to Consolidate filed herein by the Osage Beach Fire Protection District should be denied, and this case should proceed for determination by the Commission as recommended by the Staff in its Staff Recommendation filed herein on December 12, 1997.

### MOTION TO SUBMIT CASE ON VERIFIED APPLICATION AND STAFF RECOMMENDATION

Based on the Verified Application herein and the attachments thereto, and the Recommendation of the Staff filed herein on December 12, 1997, this case is ready for submission to the Commission for determination, without a hearing. Neither the Applicant, the Staff, nor the Office of Public Counsel has requested a hearing herein, and this case may, pursuant to its Order of October 29, 1997, grant the relief requested based on the verified Application herein.

WHEREFORE, Applicant prays for an Order of this Commission adopting the recommendations of the Staff herein as set out in the Staff Recommendation filed herein on December 12, 1997 and as set forth above, and Denying the Motion to Consolidate filed herein by the Osage Beach Fire Protection District on December 12, 1997, and take upon and consider the Application herein, as hereby amended, upon the Verified Application and Attachments thereto, and upon such consideration, issue its Order Granting Applicant a certificate of convenience and necessity to provide sewer service to Cedar Glen, and a certificate of convenience and necessity to provide water service to Cedar Glen as prayed for in the Application, as amended.

## Osage Water Company to serve Cedar Glen condos

CAMDENTON – Osage Water Company has announced plans to provide public water and sewer utility service to the Cedar Glen Condominium project currently under construction on Lake Road 54-79 near the Lake Valley Country Club west of Camdenton.

In conjunction with the developer of the condominium, the company is constructing a public drinking water supply system to provide safe drinking water to condominium residents and a recirculating sand filter treatment to treat and safely dispose of the wastewater from the project. Both the water and sewer systems are designed to be expandable to provide service to adjoining properties, if needed.

A sand filter system provides the advantage of treating the affluent, or water, for a standard septic tank so that it is safe for direct disposal. This means that it can be readily adapted to "retro-fit" existing septic systems by installing an effluent pump and eliminating the lateral field.

The company has been operating a septic tank and sand filter system at Cimmaron Bay Subdivision on Shawnee Bend 5 since 1996. The systems appear to be an effective and environmentally safe way to treat sewage from a large number of residential dwellings, whether in a condominium or a lakefront subdivision. Because the effluent is treated off-site, concerns about the percolation characteristics of the soil, or the location of the septic system too close tot he lake, are eliminated.

Osage Water Company is a Public Service Commission-regulated, investor-owned water and sewer utility company and has been in business in Osage Beach since 1987.
