ORDER DIRECTING FILING

The Commission is considering Union Electric Company's pending Request for Mediation of the immediate case, in accordance with instructions outlined in the Notice of Complaint, dated September 4, 2001. Finally, Respondents understand that if the Complainants decline the opportunity to seek



mediation, Respondents will be notified in writing that the tolling has ceased and the date by which an answer or notice of satisfaction must be filed.

IT IS THEREFORE ORDERED:

- 1. That Complainants shall file a response to the request for mediation not later than 2:00 p.m., Friday, October 5, 2001, as directed above.
 - 2. That this order shall become effective on September 25, 2001.
