ORDER APPROVING TARIFF IN COMPLIANCE WITH COMMISSION ORDER

The Commission approved an increase in water and sewer rates for Missouri-American Water Company (MAWC) by Report and Order issued on November 6, 1997. The Commission directed MAWC to file tariff sheets reflecting increases of \$2,703,800 in water revenues, and \$3,100 in sewer revenues, in compliance with the Report and Order and the approved stipulation of the parties. The company filed the required tariff sheets on November 12 with an effective date of November 12. The company also filed a motion for expedited treatment. MAWC filed one substitute sheet on November 12 and extended the effective date to November 14.

The Commission's Staff reviewed the tariff sheets and filed a memorandum on November 12, recommending that the Commission approve them for service on and after November 14. Staff stated that the tariff sheets comply with the Commission's ordered revenue increase and rate design and should be approved.

The Commission has reviewed the tariff sheets, the motion for expedited treatment, and the Staff's recommendation. The Commission finds that expedited approval is appropriate and that the tariff sheets conform to the Commission's order of November 6, and should be approved as amended by the substitute sheet to become effective on November 14.

IT IS THEREFORE ORDERED:

1. That the tariff sheets filed by Missouri-American Water Company on November 12, 1997, are approved to become effective on November 14, 1997. The tariff sheets approved are:
