- 1. After the Staff had filed a <u>Status Report</u> on May 9, 2006<sup>1</sup>, the Commission issued its <u>ORDER DIRECTING STAFF TO FILE STATUS REPORTS</u> ("Order") on May 12<sup>th</sup>, in which it ordered the Staff to submit monthly status reports on or before the 15<sup>th</sup> of each month until such time as a recommendation can be filed, or unless otherwise ordered by the Commission.
- 2. In compliance with the Commission's Order, the Staff submitted its <u>Second Status</u>

  Report on June 15<sup>th</sup>, its <u>Third Status Report</u> on July 12<sup>th</sup>, its <u>Fourth Status Report</u> on August 15<sup>th</sup>, its <u>Fifth Status Report</u> on September 15<sup>th</sup>, and its Sixth Status Report on October 12<sup>th</sup>.
- 3. For this <u>Seventh Status Report</u>, the Staff reports a draft of an engineering report, which was reported as under review by the District's operations staff, is still under review, and no action has yet been taken by the District's board. There is, therefore, no substantial activity to report at this time.
