APPLICATION

COMES NOW Cordia Communications Corp. ("Cordia" or "Applicant") requests a Certificate of Service Authority to provide competitive intrastate interexchange telecommunications services between and among locations within the state of Missouri pursuant to Section 392.440 RSMo (2000)¹, an order classifying Applicant as a competitive telecommunications carrier, and an order waiving or suspending certain Commission rules and statutory provisions pursuant to Section 392.440, and an order waiving or suspending certain Commission rules and statutory provisions pursuant to Section 392.420. In support of its request, Applicant provides the following information:

1. Applicant is a corporation organized under the laws of Nevada. Its principal office is located at:

2. Cordia Communications Corp. proposed to offer long distance service provided through underlying carriers who have been selected for the best combination of quality and price. Each customer is presubscribed to the underlying carrier's network. In turn, the underlying carrier identifies the ANI of the Cordia customer and periodically sends the call detail to Cordia for billing. Cordia provides a toll free number for inquiries and repair. At this time, operator assisted calls are routed to the underlying carrier who brands and bills these calls at its tariffed rates.

3. Cordia's statutory representation in the state of Missouri is:

- 4. Cordia intends to provide resold long distance telecommunications service on a twenty-four (24) hour a day basis, originating and terminating throughout the state of Missouri.
- 5. Cordia possesses managerial and technical expertise to provide resale interexchange telecommunications services.
- 6. Cordia has ample financial resources to operate as a telecommunications reseller.
- 7. Cordia's tariff contains the rules and regulations applicable to its customers, a description of the services offered, and a list of rates associated with such services is being filed simultaneously with this application showing a forty-five (45) day effective date.
- 8. Cordia requests classification as a competitive telecommunications company operating within the state of Missouri. Cordia further requests classification of services described in Cordia's tariff as competitive services.
- 9. Applicant will not unjustly discriminate among its customers, which discrimination is prohibited pursuant to Section 392.200.
- 10. Applicant, pursuant to Section 386.570, will comply with all applicable Commission rules except those which are specifically waived by the Commission pursuant to a request filed by the Applicant.
- 11. Cordia Communications Corp. does not offer Operator Service.

The above referenced rules and statutory provisions have been waived with regard to other interexchange carriers in prior cases. These rules or statutory provisions are principally designed to apply to noncompetitive telecommunications carriers. It would be inconsistent with the goal and purpose of Section 392.530 to apply them to a competitive telecommunications carrier such as the Applicant.

WHEREFORE, Cordia Communications Corp. respectfully requests the Commission to grant it a certificate of service authority to offer competitive intrastate interexchange telecommunications service within the state of Missouri; an order classifying it as a competitive telecommunications company providing competitive service; an order suspending, waiving or modifying the above referenced rules and statutory provision as they relate to the regulation of the Applicant in the state of Missouri, and for such further orders as the Commission deems appropriate.


