MOTION TO COMPEL**

On January 27, 2017, the Staff of the Missouri Public Service Commission filed a Motion to Compel stating that Elm Hills Utility Operating Company, Inc. ("Elm Hills") failed to submit responses to certain data requests or provided insufficient answers to other data requests. At an informal discovery conference on January 18, Elm Hills' representative stated that all responses would be provided to Staff by January 25. Staff states that the responses are necessary to allow Staff to perform a review of the application to transfer Elm Hills' assets to Missouri Utilities Company.

The Commission will set a deadline for Elm Hills to file a response to the Motion to Compel.

**THE COMMISSION ORDERS THAT:**

1. No later than January 30, 2017, Elm Hills shall file a response to Staff's Motion to Compel.

2. This order shall be effective when issued.
