4	Joint Application of House Springs Sewer Company,
5	Incorporated and Jefferson County Public Sewer District

7	to Sell Company Assets to Jefferson County Public Sewer

All right. I have convened this conference
to give the parties a chance to talk about this case.

with this case?

following Friday, that would give me a little more time
in the office, just if issues would arise.
