On August 15, 2000, Union Electric Company d/b/a AmerenUE filed with the Commission eight (8) tariff sheets with a proposed effective date of September 14, 2000 to reflect the changes to its Missouri service area as a result of its Territorial Agreement with Lewis County Rural Electric Cooperative, approved by the Commission in its REPORT AND ORDER (Order) issued July 21, 2000, effective August 1, 2000. On August 28, 2000, Union Electric Company filed a substitute tariff sheet to correct typographical errors as requested by the Missouri Public Service Commission Electric — Tariff / Rate Design Staff (Staff).

In its Order the Commission ordered UE to file revised tariff sheets in compliance with the Territorial Agreement and incorporating the changes to the illustrative tariff sheets filed with the joint application stipulated to by the parties of the Unanimous Stipulation and Agreement.

The Staff has reviewed the filed tariff sheets and is of the opinion that they were timely filed and are in compliance with the Commission's Order and the Unanimous Stipulation and Agreement. Staff is not aware of any other matter before the Commission that affects or is affected by this filing.
