

SUBJECT: Staff Recommendation For **Approval** of Tariff Sheets Filed To Comply With The  
Commission's Report And Order Issued January 24, 2002

DATE: March 7, 2002

On February 20, 2002, Union Electric Company, d/b/a AmerenUE (UE) filed with the Commission four (4) tariff sheets with a proposed effective date of March 21, 2002 to reflect the changes to its Missouri service area as a result of its Territorial Agreement with Gascosage Electric Cooperative, approved by the Commission in its Report And Order (Order) issued January 24, 2002, effective February 3, 2002. On March 5, 2002, UE filed substitute tariff sheets to correct the effective date to provide at least 30 days notice, making it March 25, 2002, as requested by the Missouri Public Service Commission Energy Department Staff (Staff).

In its Order the Commission directed that UE file revised tariff sheets in compliance with the First Amendment to Territorial Agreement approved in Ordered Paragraph 1. Such filing was to be made by no later than March 5, 2002.

The Staff has reviewed the filed tariff sheets and is of the opinion that they were filed in a timely manner and are in compliance with the Commission's Order and the First Amendment to Territorial Agreement. Staff is not aware of any other matter before the Commission that affects or is affected by this filing. Staff therefore recommends that the Commission issue an order approving the following proposed tariff sheets, as filed on February 20, 2002, and substituted on March 5, 2002, to become effective on March 25, 2002:
