

Subject: Staff recommendation on locations for Public Hearing Sites

Date: March 10, 2000

On March 1, 2000, the Missouri Public Service Commission (Commission) requested that Staff propose locations for public hearings in the 314/636 and 816 NPAs. Based on a March 7, 2000 meeting with parties to this case, including the Office of the Public Counsel, it was suggested the Commission hold one public hearing in the 314 area, one in the 636 area and three hearings in the 816 area code. This proposed schedule differs from Staff's recommended schedule as proposed on February 14, 2000. Three public hearings are being proposed for the 816 area code in order to accommodate the larger geographic area encompassed by the 816 area code. Staff has no objections to the following proposed locations listed below:

- Wainwright State Office Building, 111N 7<sup>th</sup> St. Rm. 116; and
- Missouri Public Service Commission branch office, 815 Charter Commons Drive, Suite 100B, Chesterfield, Missouri.

The Staff suggests that public hearings for the 816 NPA be held at the following locations:

- Kansas City Legislative Assembly Area, Jackson County Courthouse, 415 East 12<sup>th</sup> Street, Room 204, Kansas City, Missouri;
- St. Joseph City Hall, 1100 Fredrick Avenue, St. Joseph, Mo; and
- Bernard C. Campbell Junior High School, 1201 N.E. Colbern Road, Lee's Summit, Missouri.
