**STAFF MOTION FOR ORDER AUTHORIZING
FILING OF ADDITIONAL TESTIMONY**

Comes now the Staff of the Missouri Public Service Commission (Staff) and requests Missouri Public Service Commission (Commission) authorization to file certain testimony on the matter of the formation of Ameren Services Company and the amended General Services Agreement between Ameren Services Company and Ameren Corporation, Union Electric Company, Central Illinois Public Service Company and CIPSCO Investment Company as related in the May 15, 1997 Staff Motion For Additional Testimony Filing Dates, and the May 17, 1997 Notice issued by the Commission. In support thereof, the Staff states as follows:

1. Consistent with the Notice issued on May 17, 1996, UE on June 3, 1996 filed the Supplemental Direct Testimony of Warner L. Baxter relating to the formation of the Ameren Services Company and the amendment of the General Services Agreement. Therein, Mr. Baxter stated that UE expected to file a final copy of the amended

General Services Agreement with the Commission by June 21, 1996. Copies of the amended General Services Agreement were filed with the Commission on June 21, 1996 as Schedule 4 to the Second Supplemental Direct Testimony of Warner L. Baxter.

2. During the week of June 17, 1996 the Staff and UE discussed dates for the filing of Staff Supplemental Rebuttal Testimony and UE Supplemental Surrebuttal Testimony on Ameren Services Company and the amended General Services Agreement. The Staff suggested and UE agreed to June 26, 1996 as the date for the filing of Staff Supplemental Rebuttal Testimony and July 1, 1996 as the date for the filing of UE Supplemental Surrebuttal Testimony.

Wherefore the Staff seeks the issuance of a Commission Notice or Order authorizing the filing of Staff Supplemental Rebuttal Testimony on June 26, 1996 and the filing of Union Electric Company Supplemental Surrebuttal Testimony on July 1, 1996 on the formation of Ameren Services Company and the amendment of the General Services Agreement.
