On August 7, 2000, Missouri Gas Energy, a division of Southern Union Company (MGE or Company) of Kansas City, Missouri, filed tariff sheets with the Missouri Public Service Commission (Commission). On August 10, 2000, MGE filed a substitute tariff sheet to correct a typographical error. The tariff sheets provide for the required 30 days notice by having a September 6, 2000, effective date. In its letter accompanying this filing, MGE is requesting expedited approval of these tariff sheets, but the Company did not request a specific date. The Company is requesting expedited approval of the tariff sheets to give MGE more available time to execute the hedging portion of the Gas Supply Incentive Plan (GSIP).

The purpose of this filing is to comply with the Commission's <u>ORDER APPROVING</u>

<u>STIPULATION AND AGREEMENT</u> (Order), issued on August 1, 2000, approving the <u>AMENDED</u>

<u>STIPULATION AND AGREEMENT</u> (Stipulation) filed on May 15, 2000. The Commission's Order requires MGE to file tariff sheets, within 30 days of the effective date of the Order, to implement the GSIP.

The Commission Staff (Staff) has reviewed the Company's tariff sheets filed August 7, 2000, and as substituted on August 10, 2000, and is of the opinion that they comply with the Commission Order and are substantially the same as the specimen tariff sheets submitted on May 19, 2000, as provided for in the Stipulation. Staff is unaware of any issue currently pending before the Commission that affects or is affected by this filing. Staff is of the opinion that this filing is in compliance with the Commission's Order and Staff has no objection to the Company's request for expedited approval. Therefore, Staff recommends that the following tariff sheets filed on August 7, 2000, and as substituted on August 10, 2000, be approved:
