### APPLICATION FOR APPROVAL OF AN INTERCONNECTION AGREEMENT

Comes now US West Interprise America, Inc. d/b/a !NTERPRISE America, Inc. ("Interprise") and hereby files this Application for Approval of their Interconnection Agreement (the "Agreement") under the Telecommunications Act of 1996, Public Law No. 104-104 ("Federal Act"). In support of this Application, Interprise states as follows:

#### INTERCONNECTION AGREEMENT REACHED

1. Interprise presents to this Commission for approval the Agreement negotiated and executed pursuant to the terms of the Federal Act. After comprehensive, good faith negotiations to address all of the complex issues involved in such an agreement, Southwestern Bell Telephone Company ("SWBT") and Interprise executed the Agreement which is filed herewith, together with various attachments incorporated therein at Exhibit 2. All matters between the parties have been successfully negotiated, and there are no outstanding issues requiring the assistance of mediation or arbitration.

### **REQUEST FOR APPROVAL**

2. Interprise seeks the Commission's approval of the Agreement, consistent with the provisions of the Federal Act and Missouri law. Interprise believes that the implementation of this Agreement complies fully with Section 252(e) of the Telecommunications Act of 1996 because the Agreement is consistent with the public interest, convenience and necessity and does not



discriminate against any telecommunications carrier. The Agreement promotes diversity in providers, provides interconnectivity, and increases customer choices for telecommunications services.

3. Interprise respectfully requests that the Commission grant expeditious approval of this Agreement, without change, suspension or other delay in its implementation. This is a bilateral agreement, reached as a result of negotiations and compromise between competitors, and Interprise does not believe a docket or intervention by other parties except SWBT, is necessary or appropriate.

#### STANDARD FOR REVIEW

- 4. The statutory standards of review are set forth in Section 252(3) of the Telecommunications Act of 1996 which provides as follows:
  - (1) APPROVAL REQUIRED.—Any interconnection agreement adopted by negotiation or arbitration shall be submitted for approval to the State commission. A state commission to which an agreement is submitted shall approve or reject the agreement, with written findings as to any deficiencies.
  - (2) GROUNDS FOR REJECTION.—The State Commission may only reject
    - (A) an agreement (or any portion thereof) adopted by negotiation under subsection (a) if it finds that
      - (i) the agreement (or portion thereof) discriminates against a telecommunications carrier not a party to the agreement; or
      - (ii) the implementation of such agreement or portion is not consistent with the public interest, convenience, and necessity:...
- 5. The affidavit of Richard J. Boyer, President and CEO of Interprise, establishes that the agreement submitted herein satisfies these standards (Affidavit, Exhibit 1).

### **CONCLUSION**

WHEREFORE, Interprise respectfully requests that the Commission approve the Interconnection Agreement between SWBT and Interprise.
