On February 23, 2000, Ionex Communications, Inc. (ICI) a competitive interexchange telecommunications company, submitted a request for consent to change the corporate name of Feist Long Distance Service, Inc. (FLDS) to Ionex Communications, Inc.

FLDS was certificated by the Missouri Public Service Commission to provide interexchange telecommunications service on March 25, 1998 in Case No. TA-98-332. The filing included an adoption notice, a revised tariff title sheet, and a copy of FLDS' Amended Certificate of Authority from the Missouri Secretary of State changing its corporate name to Ionex Communications, Inc.

The Telecommunications Department Staff (Staff) has no objections to the name change and recommends the Commission amend FLDS' certificate of service authority to reflect the new company name. All pages of the original tariff (Missouri Tariff No. 1, Original Page No. 1 through Original Page No. 45) remain the same, except for the name change.

The Staff is unaware of any other filing that affects, or would be affected by, this filing.
