

DATE: March 9, 2001

On March 5, 2001, Kansas City Power & Light Company (KCPL) filed with the Commission two (2) tariff sheets with a proposed effective date of April 16, 2001 to reflect the changes to its Missouri service area as a result of its Territorial Agreement with City of Marshall, approved by the Commission in its REPORT AND ORDER (Order) issued January 23, 2001, effective February 2, 2001.

In its Order the Commission directed that KCPL file revised tariff sheets with respect to its service area in Saline County. Such filing was to be made by no later than March 5, 2001.
