STAFF RECOMMENDATION ON COMPLIANCE TARIFF SHEETS

COMES NOW Staff of the Missouri Public Service Commission, and submits its Staff Recommendation on Compliance Tariff Sheets and in support thereof respectfully states as follows:

- 1. On October 3, 2019, KCP&L Greater Missouri Operations Company¹ ("GMO" or "Company") filed what it denominated as a Stipulation and Agreement ("Stipulation"), along with the testimony of Linda J. Nunn in support of the Stipulation. Attached to Ms. Nunn's testimony were, among other things, exemplar or sample tariff sheets.
- 2. After discussions between GMO and Staff regarding the Stipulation and the exemplar tariffs submitted by GMO, on November 12, 2019 GMO filed a Notice of Changes to Exemplar Tariffs, along with new exemplar tariff sheets to address matters raised by Staff.
- 3. On December 3, 2019, the Commission issued an *Order Approving Stipulation and Agreement and Directing Filing of Compliance Tariffs* which directed GMO to file compliance tariffs consistent with the revised exemplar tariffs [the exemplar tariffs as amended on November 12, 2019].

- 4. On December 4, 2019, GMO filed proposed compliance tariffs², and on December 5, 2019, the Commission issued an *Order Directing Filing* which ordered Staff to file a recommendation regarding the compliance tariffs no later than December 12, 2019.
- 5. The proposed compliance tariff sheets were filed as Tariff Tracking No. YH-2020-0095 and consisted of the following tariff sheets:
