STAFF'S MOTION FOR LEAVE TO LATE FILE STAFF'S INITIAL BRIEF

COMES NOW the Missouri Public Service Commission Staff (Staff) and files the instant motion requesting that the Missouri Public Service Commission (Commission) grant the Staff leave to late file Staff's Initial Brief in this case. In support of its motion the Staff states as follows:

- 1. Under the original procedural schedule set by the Commission, Initial Briefs were due August 28, 2000.
- On August 23, 2000, in response to the Staff's motion for an extension of time to 2. file Initial Briefs and Reply Briefs based on disruption that resulted from the move of the Commission's office, the Commission extended the filing date of the Initial Briefs to September 5, 2000 and the Reply Briefs to September 29, 2000, for all parties.
- 3. Despite the Staff's attempt to meet the extended filing deadline, due to the press of other Commission matters as well as unplanned for difficulties in assembling into a single document numerous sections drafted by different authors using different formatting, the Staff did not meet the filing deadline. Resolving the formatting problems consumed much of the day and into the evening of September 5, 2000. The Staff has not reviewed any other party's Initial Brief

for the purpose of preparing its own Initial Brief. The Staff submitted for filing after 4:00 p.m. on September 5, 2000, the Staff's notice to the Commission and other parties that the Staff had not timely filed the Staff's Initial Brief. The Staff's Initial Brief is submitted for filing contemporaneously with this motion for leave to late file the Staff's Initial Brief.

4. The delay in Staff's submission to the Commission for filing of its Initial Brief was not done for the purpose of delay or to cause prejudice to any party. The undersigned Staff counsel again apologizes for the inconvenience to the Commissioners, Regulatory Law Judge, and parties to this proceeding.

WHEREFORE, the Staff requests that the Commission grant the Staff leave to late file its Initial Brief.
