**APPLICATION**



- (d) Any applicable license tax;

(6) That the Applicant will remit the annual assessment imposed by the Commission under section 386.370, RSMo;

(7) That the Applicant will file with the Commission an annual report at a time and covering the yearly period fixed by the Commission;
