On October 10, 2000, Union Electric Company d/b/a AmerenUE filed with the Commission three (3) tariff sheets with a proposed effective date of November 9, 2000 to reflect the changes to its Missouri service area as a result of its Territorial Agreement with Intercounty Electric Cooperative Association, approved by the Commission in its REPORT AND ORDER (Order) issued August 31, 2000, effective September 11, 2000.

In its Order the Commission ordered UE to file revised tariff sheets in compliance with the Territorial Agreement and incorporating the changes stipulated to by the parties in the Unanimous Stipulation and Agreement. Such filing was to be made by no later than October 11, 2000.
